As a minimum, units will use this policy directive in conjunction with the annual unit self-assessment. The objective is to identify deficiencies that preclude attainment of required capabilities. This policy directive may be used in whole or in part by HHQ/IG during evaluations and exercises. Proponent: NGB/CFC. Distr: F.

NG Pam 600-22/ANGP 36-3, Investigating Military Discrimination Complaints. This pamphlet will assist investigators in the conduct of discrimination complaints investigations filed in accordance with NGR 600-22/ANGI 36-3. It provides models for analyses and a format for preparation of reports of investigation. This pamphlet applies to the Army National Guard and Air National Guard military personnel filing discrimination complaints under NGR 600-22/ANGI 36-3. Proponent: NGB-EO. Distr: B/F.
