1. National Guard Bureau Publications and Blank Forms.

a. Announcement of New Publications and Forms. This paragraph reflects the purpose of new publications and forms. For new publications this paragraph cites: Publication type, series numbers, complete title, purpose, applicability, proponent, and distribution. For new forms this paragraph cites: Form type, series numbers, complete title, date, proponent, and prescribing directive (type, series numbers and date). Requirements for publications listed in this paragraph must be submitted to NGB-SDP, DSN 476-4212, Augusta, Maine, not later than 31 October 2003. Return to your local Pubs Office by: _____.

NG Pam 415-5, Army National Guard Military Construction Program Execution. Purpose being to provide procedures and guidance to the Construction and Facilities Management Officer (CFMO) on programming and executing a military construction program. The pamphlet emphasizes completion of DD Forms 1390/1391, submittal of design documents, and construction contract management procedures. This publication applies to all Army National Guard construction funded in whole or in part with a military construction appropriation. The proponent is NGB-ARI and the distribution is B.

NG Pam 420-10, Construction and Facilities Management Office Procedures. Purpose being to provide procedures and guidance to the Construction and Facilities Management Officer on the management of State level public works activities and emphasizes the execution of the Facilities Programs, especially in the areas of work classification, project documentation, and project execution. Publication applies to Army National Guard construction and facilities management operations, no matter the funding source or project initiator. This regulation does not directly pertain to activities associated with the execution of a military construction appropriation. The proponent is NGB-ARI. Distribution is B.

NGR 750-51; Command Maintenance Evaluation Team. This regulation establishes the responsibilities, scope, policies, procedures, and checklists for the Command Maintenance Evaluation Team (COMET) program. It does not prohibit or replace the formal or informal inspection of maintenance programs conducted at the discretion of commanders at any level. This regulation will be used in conjunction with other regulations and publications to form a solid maintenance and supply (Class IX) program. This includes AR 750-1 as applicable to ARNG units. Proponent is NGB-ARL; distribution is A.
