Full functionality of the DA fillable Adobe (.pdf) forms requires either Adobe Acrobat 10 or higher or Adobe Reader 10 or higher. As required by the Department of the Army policy, the National Guard Bureau will be converting all its existing forms to fillable Adobe (.pdf) in a systematic process and will only publish new forms in the fillable Adobe (.pdf) format.
- (2) NGB will continue to host existing IBM Lotus (.xfdl) forms, on the NGB website until 01 April 2015. Any revisions to a NGB Form will only be made to the fillable PDF version, and the .xfdl format version will be removed at that time.
