NG-J1 NGB-SL DISTRIBUTION: A CNGBI 1001.01 29 June 2016

Incorporating Change 1, Effective 08 April 2024

NATIONAL GUARD JOINT FORCE HEADQUARTERS-STATE

- 1. <u>Purpose</u>. This instruction establishes policy and assigns responsibilities for National Guard (NG) Joint Force Headquarters-State (NG-JFHQs-State) manpower planning, to establish the "Joint Element," in each State, Territory, and the District of Columbia (hereinafter referred to as "States") in accordance with (IAW) the references.
- 2. <u>Cancellation</u>. This instruction cancels and replaces CNGB Instruction 1001.01, 29 June 2016, "National Guard Joint Force Headquarters-State."
- 3. Applicability. This instruction applies to all elements of the NG.
- 4. <u>Policy</u>. It is NGB policy to establish 54 NG JFHQs-State, one in each of the States, composed of NG leadership of that State, to support Federal missions defined in reference a, and State missions, as appropriate.
- a. Initial NG JFHQs-State "Joint Element" billets are established in the approved Table of Distribution and Allowances (TDA) authorizations for the Army National Guard (ARNG), and the Air National Guard (ANG) Unit Manning Document (UMD), of the headquarters of each State.
- b. The "3432+4" Requirements in Enclosure A specify "baseline" maximum staffing for each NG JFHQs-State to execute Federal requirement, and in conjunction with the recommended organization structure in Enclosure B, allow the ARNG and ANG to recognize "Joint Element" positions in the ARNG TDA and ANG UMD.
- c. The Adjutants General (TAG) of the States, Territories, and the Commanding General of the District of Columbia NG (CG) have maximum flexibility, within the

parameters of the "3132+4" Requirements, to size and organize the "Joint Element" of their respective NG JFHQs-State to meet existing Federal mission requirements.

- 5. <u>Definitions</u>. See Glossary.
- 6. Responsibilities.
- a. <u>TAGs and CG</u>. TAGs and the CG, under the authority, direction, and control of their Governors or chain of command, will-should:
- (1) Use the "3432+4" Requirements to populate the "Joint Element" of the respective NG JFHQs-State within the recommended manpower limits, and with appropriate risk assessments to meet Federal and individual State mission requirements.
- (2) Forward requests for additional manpower resources for the NG JFHQs-State "Joint Element" to the ARNG Personnel Division (ARNG-G1) or ANG Manpower and Personnel Division (NGB-A1) NG Joint Staff Directorate of Manpower and Personnel (NG-J1) for consideration and coordination IAW reference a.
 - b. <u>Directors of the ARNG (DARNG) and Director of the ANG (DANG)</u>. The DARNG and the DANG will:
- (1) Take the necessary steps, within their respective Service manpower processes, guidelines, and resource constraints, to document and incorporate the "3132+4" Requirements as a tool to assist the NG JFHQs-State in carrying out their responsibilities as defined in reference a.
- (2) Assist in validating the NG JFHQs-State "Joint Element" manpower requirements to obtain the required manpower resources through Service budget processes.
- c. <u>Director of NG-J1</u>Director of NGB Senior Leader Management Office (NGB-SL). The Director of NGB-SL will:
- (1) Assist the DARNG and DANG in validating the manpower requirements for the "Joint Element" of the NG JFHQs-State in compliance with required Service processes and procedures.
- (2) Assist TAGs and the CG in complying with joint manpower policies and procedures.

- 7. <u>Summary of Changes</u>. This instruction has been updated to add a Command Senior Enlisted Position to the NG JFHQs-State Requirements Menu and reassign responsibilities from the Director of Manpower and Personnel to the Director of NGB-SL.
- 8. <u>Releasability</u>. This instruction is approved for public release; distribution is unlimited. It is available at https://www.ngbpmc.ng.mil.
- 9. <u>Effective Date</u>. This instruction is effective upon publication and must be reviewed annually by the Proponent/Office of Primary Responsibility for continued validity, and revised, reissued, canceled, or certified as current every—five ten years.




Figure 1. NG JFHQs-State Organization Structure
