- 1. <u>Purpose</u>. This instruction establishes policy and assigns responsibilities for National Guard (NG) litigation concerns in accordance with (IAW) references a through d.
- 2. <u>Cancellation</u>. This instruction replaces National Guard Regulation 27-40/Air National Guard Regulation 110-24, 31 August 1981, "Litigation."
- 3. Applicability. This instruction applies to all elements of the NG.
- 4. <u>Policy</u>. It is National Guard Bureau (NGB) policy to monitor and provide guidance through the Office of the NGB Chief Counsel (NGB-JA) on all litigation arising from or related to activities or interests of the NG.
- 5. <u>Definitions</u>. See Glossary.
- 6. Responsibilities. See Enclosure A.
- 7. Summary of Changes. This is the initial publication of CNGBI 0405.01.

- 8. <u>Releasability</u>. This instruction is approved for public release; distribution is unlimited. Copies are available through http://www.ngbpdc.ngb.army.mil.
- 9. <u>Effective Date</u>. This instruction is effective upon publication and must be reissued, cancelled, or certified as current every five years.

ENCLOSURE A

RESPONSIBILITIES

1. NGB-JA. NGB-JA will:

- a. Serve as the official channel of communication on all legal matters, including litigation, pertaining to the NG between the States and the Department of the Army and the Department of the Air Force IAW paragraph 4b of reference d.
- b. Receive all litigation-related inquires and requests from other Federal agencies.
- c. Maintain and distribute a current roster of NG Litigation Coordinators (LC) to the U.S. Army Legal Services Agency Litigation Division, and the Air Force Legal Operations Agency Civil Law and Litigation Directorate.
- d. Develop, coordinate, and issue a CNGB Manual to provide implementing guidance, including required reports and notifications, IAW with this instruction.
- 2. The Adjutants General (TAG) and the Commanding General of the District of Columbia National Guard (CG). TAGs and the CG will designate a full-time, military technician (dual status) or Active Guard Reserve, Judge Advocate as a LC.

3. LCs. LCs will:

- a. Serve as the point of contact between their respective State and the NGB for all litigation matters.
 - b. Prepare litigation reports after coordination with NGB-JA.
- c. Refer all litigation-related inquiries and requests from other Federal agencies to NGB-JA.
 - d. Prepare and transmit any required litigation notifications to NGB-JA.
- e. Provide NGB-JA with the LC's updated contact information, including the LC's name, rank, official email address, street address, facsimile number, and duty phone number (both Defense Switched Network and commercial where applicable).
