NGB-J1 CNGBI 1100.01A DISTRIBUTION: A 31 July 2020

PROHIBITED EXTENSIONS OF TITLE 32 ORDERS FOR USE OF LEAVE

- 1. <u>Purpose</u>. This instruction provides guidance to the National Guard regarding the prohibition of extending Title 32 orders for the sole purpose of using accrued leave.
- 2. <u>Cancellation</u>. This instruction cancels and replaces its previous edition, CNGBI 1100.01, 08 April 2013, "Prohibited Extensions of Title 32 Orders for Use of Leave."
- 3. <u>Applicability</u>. This Instruction applies to all States, Territories, and the District of Columbia and to all elements of the National Guard Bureau where Reserve Component members are serving under Title 32 orders.
- 4. <u>Policy</u>. Title 32 orders will not be extended for the sole purpose of using accrued leave. In accordance with reference a, Enclosure 2, paragraph 1.b (7), and references b, c, and d, a Reserve Component member who accumulates leave during a period of active service may carry over the accumulated leave to the next period of active service, subject to the accumulation limits in reference d, and without regard to separation or release from active service under honorable conditions.
- 5. Definitions. None.
- 6. <u>Responsibilities</u>. All commanders must ensure that Reserve Component members are provided the opportunities to use leave before the end of their tour.
- 7. Summary of Changes. None.
- 8. <u>Releasability</u>. This instruction is approved for public release; distribution is unlimited. National Guard Bureau directorates, The Adjutants General, the
