1. Purpose. This notice implements reference a, and it establishes the organization of the four major organizational elements of the National Guard Bureau (NGB). This notice further reinstates the Personal and Special Staff elements within the Office of the Chief of the National Guard Bureau (OCNGB), in accordance with reference b.
2. Cancellation. This notice supersedes all previous applicable organizational documents.
3. Applicability. This notice applies to the NGB.
4. Background. The Director of Manpower and Personnel (NGB-J1) is the proponent and office of record for this document. The NGB-J1 will coordinate preparation, staffing, and publication of this notice, as well as subsequent Chief of the National Guard Bureau (CNGB)-directed reviews
5. Action or Procedure. See Enclosures A through D.
6. Releasability. This notice is approved for official release; distribution is unlimited in official channels. The NGB directorates and offices, The Adjutants General, the Commanding General of the District of Columbia National Guard

ENCLOSURE A

ORGANIZATION OF THE OFFICE OF THE CHIEF OF THE NATIONAL GUARD
BUREAU

1. The OCNGB consists of the OCNGB executive element (NGB-ZA), the Chief of the National Guard Bureau Personal Staff (CNGBPS), and the Chief of the National Guard Bureau Special Staff (CNGBSS).
2. The OCNGB executive element, NGB-ZA consists of the CNGB, the Vice Chief of the National Guard Bureau (VCNGB), the Senior Enlisted Advisor (SEA), and supporting administrative positions.
3. The CNGBPS consists of the following offices:
 - a. Office of the NGB Chief Counsel (NGB-JA).
 - b. Office of the Inspector General (NGB-IG).
 - c. Chief's Action Group (NGB-CAG).
 - d. Political Advisor (NGB-ZI).
4. The CNGBSS consists of the following offices:
 - a. Office of Equal Opportunity (NGB-EO).
 - b. General Officer Management Office (NGB-GOMO).
 - c. Office of the Joint Surgeon General (NGB-JSG).
 - d. Legislative Liaison (NGB-LL).
 - e. Office of the NGB Joint Chaplain (NGB-OC).
 - f. Operational Contracting Director (NGB-AQ).
 - g. Office of Protocol (NGB-OP).
 - h. Office of Public Affairs and Strategic Communications (NGB-PA).
 - i. Office of the Principal Assistant Responsible for Contracting (NGB-OPARC).
 - j. Office of Small Business Programs (NGB-SBP).
 - k. Joint Actions Control Office (NGB-JACO).
5. Under the authority, direction, and control of the CNGB, the offices of the CNGBPS provide advice and planning on strategic and legal matters to enable the CNGB, VCNGB, Director of the Army National Guard (DARNG), and

Director of the Air National Guard (DANG) to fulfil their statutory and regulatory responsibilities. Under the authority, direction, and control of the VCNGB, the offices of the CNGBSS provide specialized functions to support the CNGB, the NGB Joint Staff (NGBJS), the ARNG Directorate, the ANG Directorate, and the NG of the States and Territories.

ENCLOSURE B

ORGANIZATION OF THE NATIONAL GUARD BUREAU JOINT STAFF

1. The NGBJS consists of the following offices and directorates:
 - a. Office of the Director of the National Guard Bureau Joint Staff (NGB-ZB), to include: Office of Diversity and Inclusion Programs (NGB-DIV).
 - b. Manpower and Personnel Directorate (NGB-J1).
 - c. Joint Intelligence Directorate (NGB-J2).
