NATIONAL GUARD CHEMICAL, BIOLOGICAL, RADIOLOGICAL, AND NUCLEAR RESPONSE ENTERPRISE SMALLPOX AND ANTHRAX VACCINE IMMUNIZATION PROGRAMS

- 1. <u>Purpose</u>. The purpose of this instruction is to implement the policies outlined in references a and b and to establish the National Guard (NG) Combating Weapons of Mass Destruction Division (NG-J39) as the office that designates National Guardsmen, assigned by unit or position, to the NG Chemical, Biological, Radiological, and Nuclear (CBRN) Response Enterprise.
- 2. Cancellation. None.
- 3. <u>Applicability</u>. This instruction applies to all States, Territories, and the District of Columbia, hereafter referred to as "States."
- 4. <u>Policy</u>. States will implement a smallpox vaccination program (SVP) and an anthrax vaccination immunization program (AVIP) for all of their NG personnel assigned to the NG CBRN Response Enterprise (CRE). Everyone assigned to the NG CRE must comply. The Adjutants General enforce this policy; their subordinate commanders implement it. Units or personnel scheduled to rotate off the NG CRE within 180 days of the date of this policy are administratively exempt from starting the subject vaccinations. Clinical and administrative policies for SVPs and AVIPs, including exception policies and references c through m, apply as well as all other laws, regulations, and policies related to the two immunization programs. Service members both permanently and medically exempt from SVP or AVIP immunizations may be retained in the NG CRE. Service members not otherwise exempt, yet refusing to comply with the terms of this guidance may be removed from the NG CRE.

- 5. <u>Definitions</u>. See Glossary.
- 6. Responsibilities.
- a. NG-J39 is the office of primary responsibility (OPR) for tracking the NG CRE's readiness status. NG-J39 establishes policies and procedures for reporting the States' NG CRE readiness.
- b. States are responsible for assigning National Guardsmen by unit and position to their respective NG CRE units and reporting these assignments in accordance with (IAW) the NG-J39 policies and procedures.
- c. States are responsible for securing the smallpox and anthrax vaccines and developing supporting vaccination programs for their respective NG CRE units. States will comply with clinical policies and vaccination reporting requirements IAW references k, l, and m.
- d. In addition to following the adverse reporting requirements outlined in references k, l, and m, States will report serious adverse reactions or accidental inoculations within 24 hours to the National Guard Bureau (NGB) Joint Surgeon's Office by calling the NG Coordination Center Team Chief. Reports must include a State point of contact and exclude personally identifiable information.
- 7. Summary of Changes. This is the initial publication of CNGBI 3502.01.
- 8. <u>Releasability</u>. This instruction is approved for public release; distribution is unlimited. - 9. <u>Effective Date</u>. This instruction is effective upon publication and must be reissued, cancelled, or certified as current within five years of its publication.
