This instruction establishes policy and assigns responsibilities to ensure Service members tasked during a domestic operation (DOMOP) with conducting personnel actions inside Joint Force Headquarters-State (JFHQ-State) Joint Operations Center (JOC), State Emergency Operations Center (EOC), or the National Guard Coordination Center (NGCC) are trained appropriately in accordance with (IAW) reference a.
- 2. Cancellation. None.
- 3. <u>Applicability</u>. This instruction applies to all elements of the National Guard Bureau (NGB).
- 4. Policy. It is NGB policy that:
- a. Service members tasked with conducting personnel actions inside a JFHQ-State-JOC, an EOC, or the NGCC during a DOMOP will complete appropriate, functional training within the first quarter of a duty assignment.

- 6. Responsibilities.
- a. <u>Directorate of Manpower and Personnel (NG-J1)</u>. The Director of NG-J1 will:
- (1) Determine the training requirements for Service members conducting personnel actions inside a JFHQ-State-JOC, an EOC, or the NGCC during a DOMOP and create those training requirements in supplementary publications.
- (2) Plan, program, and budget for courses identified in reference c and for training needs identified by the States, Territories, and the District of Columbia.
- b. The Adjutants General (TAG) and the Commanding General of the District of Columbia (CG). TAGs and the CG will:
- (1) Identify personnel training needs, shortfalls, and limitations to providing training mandated by this publication and any supplementary issuances.
- (2) Ensure sufficient funding and class allocations are available for Service members to meet training requirements set forth in this instruction and in any supplementary issuances.
